

Groupon International Travel GmbH - £200 Groupon Credit

This page sets out the Terms and Conditions applicable to the Groupon International Travel GmbH - £200 Groupon Credit Draw, which is a free prize draw. This is a legal document which is the agreement between you (whom we refer to as "you", "your" or "entrant") and us. We are Groupon International Travel GmbH (trading as Groupon Travel) and we are the promoter of the Groupon International Travel GmbH - £200 Groupon Credit Prize Draw. We are a company registered in Switzerland with our registered office at Vordergasse 3, 8200 Schaffhausen, Switzerland (and we refer to ourselves as "Groupon Travel" "we", "us" or "our" in this document). We are a separate company from MyCityDeal Limited (trading as Groupon UK) (referred to below as "Groupon UK").

1.1 To enter this free prize draw you simply need to buy a free voucher on the deal page for the Groupon International Travel GmbH - £200 Groupon Credit Prize Draw.

1.2 From the total number of eligible entrants, one winner will be selected at random

1.3 The prize draw will be open to entrants beginning on 00:00 (BST) Monday, 15th April 2019.

1.4 The prize draw will remain open until 23:59 (BST) Monday, 22nd April 2019. Any entries received after 23:59 (BST) Monday, 22nd April 2019, are ineligible for consideration. Alternatively, the prize draw will be closed early if 100,000 entries are received.

2. Eligibility

2.1 Entrants must be aged 18 years or older.

2.2 Groupon Travel accepts no responsibility for entries that fail to be received or delivered. Proof of submission is not proof of entry.

2.3. Groupon Travel reserves the right to verify the eligibility of entrants and may deny anybody entry at its sole discretion. Groupon Travel does not accept liability for any ineligible entries.

2.4. Groupon Travel may request any relevant information it views as reasonably necessary to verify eligibility. Failure to provide such information upon request will result in Groupon Travel denying eligibility for the prize draw.

2.5. The prize draw is only open to individuals who have a Groupon UK account.

3. The Prize

3.1. There will be one winner of the prize draw.

3.2. The prize is as stated on the deal page that links to these terms and conditions.

3.3. The prize is non-transferrable

3.4. You are not entitled to obtain another product or cash alternative from us.

3.5 Should Groupon Travel be unable to provide the prize as listed it reserves the right to provide a substitute prize of similar value.

4. Selecting the Winner

4.1. From the total number of eligible entries who have purchased an entry to the prize draw, one winner will be selected at random.

4.2 The winner will be contacted via the email address registered with their Groupon UK account from which they purchased the winning voucher by 18:00 (BST) Tuesday, 30th April 2019. The winner will be instructed to confirm acceptance of their prize and provide a contact telephone number.

5. Claiming your Prize

5.1. If Groupon Travel does not receive the acceptance email from the winner within seven days after notification is provided, Groupon Travel reserves the right, within its sole discretion, to deem the prize as unaccepted and to offer the prize to an additional entrant.

5.2. If the prize is not accepted by the winner in accordance with the terms above, Groupon Travel may, within one day, randomly select an additional winner via the same process used to select the initial winner. Such subsequent winner will be notified as per clause 4.2 save that such notification will be after 18:00 (BST) Tuesday, 30th April 2019.

5.3. Once the prize is accepted, Groupon Travel will be in contact with the winner to explain how to receive the prize.
